Brian is a dedicated pro bono attorney for Prairie State Legal Services, representing poor persons with legal problems, for free. He has represented 80 pro bono Prairie State clients.

His most recent work with Prairie State has been to assist individuals facing eviction at Prairie State's courthouse eviction clinic. Brian helped recruit other State Farm attorneys and paralegals to help Prairie State handle the backlog of evictions that were filed after the eviction moratorium was lifted after 1.5 years. Brian also assists Prairie State clients in receiving legal assistance and consultations for their options for criminal records relief when eligible and prepares petitions to expunge or seal their records.
